A STRONG, SECURE AND UNSHAKABLE SUPPLY CHAIN

MINING

Extracting mineral containing material (ore) from the earth, or occasionally other sources such as tailings or waste piles.

REFINING

Removing impurities from concentrates after processing and rendering the contained minerals into a relatively pure state for commercial application.

PROCESSING

Processing mined ore to separate the valuable minerals from the waste, often resulting in the production of a "concentrate."

METALLURGY

Purifying metals, including in the "processing" or "refining" stage, and forming alloys.

MANUFACTURING

Fabricating the metals and alloys into components or finished goods.

Darrell M. Blocker is currently serving as the Vice Chairman for MOSAIC Security, a strategic intelligence, crisis management, and executive advisory firm. He retired after a successful 32-year career in the U.S. Intelligence Community earning the CIA's Distinguished Career Intelligence Medal in 2018. He served four years as an Analyst/Briefer in the U.S. Air Force (1987-1990) and 28 years as a CIA operative (1990-2018). His CIA career highlights include serving as Chief of their iconic training facility, Deputy Director of the Counterterrorism Center, Chief of Africa Division, and multiple tours as a Chief of Station. At the time of his retirement, Darrell was the most senior black officer in the CIA's Directorate of Operations with the rank equivalency of a three-star general.
